Summer reminders

With warm weather nearing, it is a good time for some general reminders to help ensure we all have a safe and enjoyable summer.

SAFE DRIVING | Please drive carefully and watch for pedestrians. During the nice weather, our neighborhood is active with people of all ages enjoying the outdoors. With the new entrance/exit setup at Foster Park due to the tunnel work, we will need to be especially careful near that intersection on busy days.

TALL GRASS | Please keep your lawn mowed below 9 inches to ensure compliance with Fort Wayne's tall grass ordinance.

FIREWORKS | State and local laws allow consumer fireworks to be discharged on select dates and times, which can be found on the City's website. Please be courteous to neighbors who may have pets or family members who do not react well to the sounds and lights from fireworks.

FIREPITS | The use of firepits is permitted but subject to various safety conditions listed on the Fire Department's website. Please reference those conditions to ensure compliance and take common sense steps to keep your backyard fires safe.

SECURITY | Take proactive steps to protect your belongings. Unfortunately, property crimes tend to increase in the summer months. We encourage all residents to take basic steps to reduce your likelihood of being targeted by a criminal. Plenty of helpful resources are available on the Fort Wayne Police Department's website.

Sidewalk Updates

Results of sidewalk survey

As part of the dues payment slip included with the December 2017 newsletter, we surveyed residents to gauge interest in the City's sidewalk replacement program. This program allows residents to split the cost of sidewalk replacement 50/50 with the City and can be completed either as individual homeowners, or as an entire block if over 51% of residents on the block agree to participate.

Survey responses received so far indicate the following level of support:

Yes, I support 32%

Open to idea 52%

No, I oppose **16%**

Note: Trends were similar when compared by street-level data.

A few respondents also noted that they recently replaced their sidewalks on their own and thus did not see the need for replacing theirs with the entire block. This is a valid point. We contacted the City and found out that even if an entire block petitions for a full replacement, sections of sidewalk in fine condition will not be replaced.

Additional information

Since there is a desire for residents to learn more, some key highlights are included below.

- Sidewalks can be replaced by individual homeowners or for the entire block (entire block requires a formal petition process).
- The cost to the homeowner is about \$100 per sidewalk slab. The City covers the other half of the cost.
- Homeowner cost can be paid in a lump sum or can be financed over 10 years at an interest rate of 3%.

Next steps

We encourage all residents on Sheridan, Branning, Lexington, and Old Mill to familiarize themselves with this program. Most importantly, we encourage these residents to attend the annual neighborhood meeting on Wednesday, May 23rd so they can share their feedback.

If enough residents show interest in moving forward with sidewalk replacement for an entire block, the board can help facilitate the petition process. If residents are not interested after learning more, we can simply let the issue go and homeowners can still replace their own sidewalks separate from their neighbors.

Dumpster Day

Details

Thanks to a program through the City of Fort Wayne, neighborhood residents will have the opportunity to dispose of unwanted solid waste materials at no cost to homeowners or the neighborhood association.

WHEN

Saturday, June 16, 2018 8:00 am – 12:00 pm

WHERE

The dumpster will be placed at 1310 W. Foster Pkwy on the north side of the street.



HOW IT WORKS

Simply gather any unwanted trash (see list below for unacceptable materials) and drop it in the dumpster during the hours noted above.

Please do not overfill the dumpster. It will not be picked up if improperly filled. Container space will be available on a first come, first served basis so plan accordingly if you wish to participate.

Unacceptable materials

The following materials **CAN NOT** be placed in the container:

Anti-freeze Chemicals
Fire Extinguishers Used Oil
Concrete Auto Fluids
Auto Parts Hazardous Waste

Oil Based Paint Explosives
Pesticides Compressed Gas
Radioactive Materials Special Waste

Tires Appliances with Freon Asphalt Fluorescent Bulbs

Freon Refrigerant Leaves Liquids Electronics

Closed Containers Items Containing Mercury

Lead Acid Batteries Herbicides

Fertilizers

*Latex paint cans need to be dried out before placing in the dumpster. They cannot accept paint in a liquid form because it may leak out onto the ground or street.
