# **Sheridan Park Strip Project**

The recently formed Beautification Committee is working on an exciting project to give new life to the center park strip located on Sheridan Court. Recent efforts were made to clean up the planting bed of weeds. The invasive Bradford pear tree was recently removed.



We are seeking feedback from residents about what they might like to see done with the planting bed space. Discussions so far have included replacing some of the current sun-loving perrenials for shade-tolerant options, or low-maintenance native plants, recutting the landscape beds, and laying fresh mulch.

The association is planning to request a neighborhood improvement grant in the winter to fund the majority of this project.

# **Seasonal Reminders**

Here are a few helpful and timely reminders to help keep our neighborhood happy and safe for all residents.

**Safe Driving** | Please drive carefully and watch for pedestrians, especially when backing out of driveways. Always stop by school buses when the stop arm is out and pay extra attention when driving near schools and bus stops.

**Leaf Pickup** | The City of Fort Wayne provides leaf pickup services from October through December. This includes two rounds of curbside leaf pickup and on-demand bagged leaf pickup via 311. Keep an eye on our Facebook page this fall for updates about leaf pickup services. Please also consider mulching your leaves to use as beneficial free compost for your yard and landscape beds.

**Pet Cleanup** | Please make sure to clean up after your dog(s) when taking them on walks throughout the neighborhood.

**Firepits** | The use of firepits is permitted but subject to various safety conditions listed on the Fire Department's website. Please reference those conditions to ensure compliance and take common sense steps to keep your backyard fires safe and controlled.

**Trash & Recycling Bins** | Please place curbside bins at least three feet apart for collection and remember to pull them back up after pickup. Reminder: plastic bags cannot be recycled.


# What We are Keeping an Eye On

Part of the value of an active neighborhood association is the ability to keep tabs on area happenings and keep residents informed. Here are some of the topics and projects we are monitoring:

- Final phases of the deep rock tunnel project, all of which are slated for completion by the end of 2025
- Foster Park restoration following utility work completion
- Potential new uses for the Summit north campus following demolition of four vacant buildings
- Bluffton Road Bridge project (tentatively 2025-2026)
- Future solar panel installation at the Summit south campus
- Tree canopy health throughout the neighborhood
- Potential future zoning or land use requests in nearby areas

# **Foster Park Golf Course Master Plan**

Following multiple public meetings and an extensive survey, Fort Wayne Parks & Recreation recently released a revised Foster Park Golf Course master plan. # **City Election and FWCS Referendum**

It is a municipal election year so our residents will have the chance to vote for Mayor, City Clerk, and City Council. The last day to register to vote or update your registration for this November's election is Tuesday, October 10<sup>th</sup>. Election Day is Tuesday, November 7<sup>th</sup>.

We will also be voting on the Fort Wayne Community Schools safety and security referendum. FWCS is asking voters within its boundaries to approve an additional tax levy to fund a variety of staff, security enhancements, and mental health

programming, all designed to support better learning environments for area K12 students.
